From the Adjutant General

This last week VFW Commander-in -Chief Duane Sarmiento, Sr. Vice Al Lipphardt, Jr. Vice Carol Whitmore, Quartermaster General Marc Garduno, and myself along with each Department's Legislative Committee had a very successful time in Washington, D.C., meeting with elected representatives about several key priorities including active-duty Transition Assistance Programs, Claim Sharks, and Veteran Suicide. Many thanks to our Washington, D.C., Legislative Services staff led by Legislative Director Pat Murray for the many hours of advance work they did to make this event successful.

At the same time Department Service Officers met in Annapolis, Maryland, for a weeklong initial and advanced skill training that helps ensure VFW Accredited Service Officers have the best training in helping support veterans with their claims. I think we can all agree that our Service Officers help change lives for the better for the tens of thousands of veterans they assist with no cost to the veteran. Thanks goes out to our Veterans Service staff led by Director Mike Figlioli for the hours they spent making this event the success it was.

Today is POW/MIA Day and Section 223 of our Bylaws and Ritual calls on us to Commemorate this day each year. The National Headquarters will be conducting a ceremony to recognize and honor American service members held as prisoners of war and those who are still missing in action.

I would like to remind all Commands that the minimum membership goal this year is 102%. Your national membership department stands ready to assist you with any questions or resources you have or need. We already have several Posts that have reached this goal and congratulations to them for setting the example. The main reason people don't join is they have not been asked, the reason they may leave is that they are not asked to be involved.

Legal Counsel

- In February, the VFW filed an Amicus Curiae brief to the Seventh Circuit Court of Appeals in support of claimants seeking relief from 3M for defective ear protection. 3M had tried to shift the blame to its subsidiary Aearo Technologies, who it said was responsible for the defective earplugs and who had filed Chapter 11 bankruptcy, to avoid paying claimants. In August, 3M settled for \$6.01 billion, consisting of \$5 billion in cash and \$1 billion in 3M stock. Payments will be made between 2023 and 2029. The bankruptcy appeal is being held in abeyance pending finalization of the settlement. It is estimated that approximately 240,000 military service members or veterans will be eligible to receive part of the settlement.
- The Justice Department and the Department of the Navy have announced an "Elective Option" for those filing claims under the Camp Lejeune Justice Act (CLJA) of 2022. The Elective Option is a potential settlement process based on diagnosis, time spent exposed to Camp Lejeune contaminated water, and if the claim involved death. There are important limitations to be mindful of for anyone interested in pursuing the Elective Option, including the latency period and limits on compensation for more than one diagnosis. Additionally, the severity of any illness is not a factor in reaching a settlement under the Elective Option. Settlements range from \$100,000 to \$450,000, based on duration of exposure and type of illness. An additional amount of \$100,000 will be offered if the exposure resulted in death. There will not be an offset for VA disability benefits or VA medical care, but the offset may apply to other federal benefits. While the Elective Option may provide immediate relief for some, those seeking relief under the CLJA should consider all their options before making a decision. Consult with competent legal counsel to determine what is the best course of action for you. National Legislative Service

• VFW Remembers 9/11: This week marks the 22nd anniversary of the terrorist attacks that changed America forever. The memories of that day are still vivid and raw in our nation's heart, but the heroism that emerged from the rubble of the World Trade Center, the Pentagon, and in the air above a rural Pennsylvania field should inspire Americans for generations to come. As we remember 9/11 and the nearly 3,000 innocent lives lost that terrible day, the VFW hopes all Americans pause to reflect on those we lost and those who continue to sacrifice in the defense of freedom.

- VFW Salutes Medal of Honor Recipient: Army pilot Capt. Larry Taylor was awarded the Medal of Honor by President Joe Biden in recognition of his heroic actions to save his fellow brothers-in-arms during the Vietnam War. With little regard for his own safety, Taylor flew into enemy fire to rescue four reconnaissance team members from almost certain death. - Op-Ed Says Don't Ground Veteran Pilots: A Washington Post op-ed penned by VFW Washington Office Executive Director Ryan Gallucci explains that using VA benefits or seeking physical or mental health care should not be an automatic disqualifier for pilots. This is especially true considering the industry is woefully understaffed and looking to the veterans' community to help solve the problem. Gallucci wrote that the VFW "respects the difficult jobs our pilots do every single day and believes that the FAA has a duty to ensure the safety of millions of Americans who travel every year.
